

THE 10TH HONG KONG LIGHTING DESIGN COMPETITION RULES & REGULATIONS



ORGANISER

The competition is organised by the Hong Kong Trade Development Council (the "Organiser").

OBJECTIVES

- 1. To enhance the creativity and design quality of Hong Kong lighting industry.
- 2. To promote Hong Kong's lighting products among international buyers.
- 3. To encourage the younger generation to join the lighting industry.

THEME OF DESIGN

Blooming Aura

The wide spectrum of light creates a unique aura for different objects in a space. Contestants' are challenged to demonstrate the feeling of liveliness and vibrancy brought about by blooming lights. Aside from functionality and aesthetics, Open Group will be assessed with higher expectations on marketability, manufacturing and sustainability than Student Group.

CATEGORY

Open Group (Hong Kong registered companies and individual designers who are Hong Kong residents)

Student Group (Hong Kong full-time students)

- ** Contestants must be from a Hong Kong registered company or a Hong Kong resident. For company contestants please attach a copy of valid Business Registration Certificate when submitting the application form. For individual designers please attach a copy of HK I.D. card when submitting the application form.
- ** Sudent Group participants must be a full-time student of a Hong Kong registered school at the time of application. Please attach a copy of student card and HK I.D. card with the application form.

DEADLINES FOR SUBMISSION OF ENTRIES

- All application forms and entries of drawings must reach the Organiser's Office (address: Unit 7, Expo Galleria, Hong Kong Convention & Exhibition Centre, 1 Expo Drive, Wan Chai, Hong Kong) on or before 12 December 2016 (Monday).
- 2. Finalists will be selected and notified individually. For the final selection, all mock-up of the finalists' designs and original drawings must reach the Organiser's Office on or before 16 February 2017 (Thursday).

RULES AND REGULATIONS

- 1. Each contestant can only participate in either Open Group or Student Group.
- 2. Each contestant may submit at maximum 3 entries. Awards are however limited to one per contestant.

- Contestants should submit a design sketch, together with a fully completed and signed application form for every entry to be eligible for the first round of judging.
- 4. The design concept, function, raw materials, accessories, colour and the actual dimensions should be stated clearly on the design sketches. Each design sketch should be mounted on no more than 2 sheets of A3 sized cardboards.
- 5. Computer aided design sketch must be free of any decorative background.
- The names of contestants or sponsors, any registered trademarks or emblems must not appear on any design sketches or mock-up of the entries submitted.
- All submissions must be original and free from infringement of any existing intellectual property rights. The Organiser and judges reserve the right to require contestants to differentiate their designs with existing designs or products in the market.
- Entries that have won awards in any local or overseas design competitions are not eligible.
- Designs undertaken on behalf of clients or made in the course of employment for an employer are not eligible.
- The Organiser reserves the right to disqualify any contestants in breach of the rules and regulations listed above.

JUDGING

Entries will be judged in two rounds:

- Originality & creativity, aesthetics, practicability and marketability will be the judging criteria. However, contestants are requested to submit information on the production details such as materials used, mechanism, etc. to justify the production feasibility of their design(s).
- 2. The judging panel will select no more than 10 finalists from each group in the first round of judging. The panel, however, reserves the right to vary the number of finalists if the quality level of entries so demands.
- 3 All finalists will be asked to construct a full scale mock-up of their designs for final selection. It will be the responsibility of the finalists to ensure that the model is an accurate interpretation of their drawings.
- 4. Finalists of student group will be reimbursed for the cost of mock-up constructions by the Organiser for up to HK\$2,000 against supporting bills. Finalists of open group should be responsible for the cost of producing mock-up.
- All finalists will be asked to present their designs for final selection. Candidates will be notified of the dates & details of the presentation session individually.



JUDGING CRITERIA

The judging panel will take into account the following factors in the selection of award winning designs.

Open Group (Student Group)

a) Originality & Creativity 35% (60%)
b) Practicability 35% (10%)
c) Aesthetics 20% (20%)
d) Marketability 10% (10%)
The decision of the judging panel will be final.

ANNOUNCEMENT OF RESULT

- Official announcement of result and presentation of awards will be made at the HKTDC Hong Kong International Lighting Fair 2017 (Spring Edition).
- All entries (except those winning ones) will be available for collection within one month from the date of announcement of the competition result.
- Samples which are not collected within the specified time will be disposed by the Organiser as it sees fit.
- The Organiser reserves the right to withhold granting of any of the prizes if it considers that the entries do not meet with the desired standard.

All winning designs will be publicised in HKTDC Exhibition Website and e-Fair Daily of the HKTDC Hong Kong International Lighting Fair 2017 (Spring Edition), HKTDC product magazine - "Hong Kong Lighting" and promotional materials such as poster and application form with regard to this competition.

ECO DESIGN AWARD

The judging panel will select ONE finalist which has incorporated the most eco-friendly elements in its design, including the overall concept, use of materials and production process.

A certificate will be presented to the winner of the 'Eco Design Award'.

MY FAVOURITE LIGHTING DESIGN AWARD

All final entries will be voted by international buyers through an online voting mechanism. The entry with the most votes will be awarded as the winner. A certificate will be presented to the winner.

COPYRIGHT AND PRODUCTION RIGHT

- Every contestant should, on entering his/her design in the competition, give an undertaking that the design is new and original and he/she is the sole owner of all copyright in and to that design.
- The Organiser will exercise maximum care in handling all entries. However, the Organiser will assume no liability for any damage or loss of any kind.
- The Organiser will not be held responsible for infringement of copyright or patent law connected with designs entered in the competition.
- 4. The copyright of all designs will remain the property of the contestants who should take proper measures to protect their own copyright of their designs. Following announcement of results, contestants are free to negotiate such rights if they so wish.

EXHIBITION & PUBLICITY

The Organiser will retain the right for printing, publishing and exhibiting the winning entries and other selected entries at its discretion.

The Organiser has absolute discretion in the admission of applicants.
